Why?

Financial companies choose how they share financial information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires how we collect, share, and protect your personal information. Please read this notice to understand what we do.

What?

The types of personal information we collect and share depend on the products and services we have with us. This information can include:

- * Social Security number and income
- * account balances and payment history
- * credit history and purchase history

When you are *no longer our customer*, we continue to share your information as described in our privacy notice.

How?

All financial companies need to share customers' personal information to run their business. In the section below, we list the reasons financial companies can share customers' personal information; the reasons Grand Chute Auto Sales of Wisconsin share; and whether you can limit this sharing.

Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> * sharing for affiliates' everyday business purposes-information about your creditworthiness * affiliates from using your information to market to you * affiliates for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and non financial companies.</p> <ul style="list-style-type: none"> * Fox Valley Finance Inc.
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and non financial companies.</p>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p>
